CONDITIONS

1. USTA and OCRA Rules to govern racing.
2. Entry Fee in all Overnight Events will be \$35 each horse entered.
3. Entry Fee for all Stakes Races \$75.
4. All entries must be received before 10:00 A.M. TWO DAYS preceding day of race.
5. Phone entries must have all information concerning name, sire and dam of horse, driver's and trainer's name.
6. Purse distribution will be 50% - 25% - 12% - 8% - 5% each dash.
7. Right reserved to race elimination dashes, change order of program, or cancel any event not receiving five or more entries.
8. Horses brought on grounds at owners' risk. The Association assumes no liability for accidents to horses, equipment, or persons, but will do everything to prevent them.
9. Signature Series Races being raced in divisions and purse divided equally. Entries for the Signature Series must be made by 10:00 A.M. three days prior to the race but will be drawn the same time as the O.C.R.A. Signature Series is a late closer. Entry Fee for Signature Series is \$100.
