Entrance fee on overnight events - 3% of advertised purse. Starting fee of \$75 on all closed races. Call in entries 3 DAY BOX. Entries close at 11:00 A.M. Entries taken from 8:00 A.M. to 11:00 A.M. **The entry fee is \$75 for the Signature Series. Signature Series events that are raced in divisions will race for an equal share of the total purse.**

We reserve the right to race any overnight double dash event in single dashes. We reserve the right to reject or refuse any entry or entries, substitute any race not filling satisfactorily, declare off or change program as conditions may require. Also, may use Rule 13, Section 2a, if necessary.

### All Horses Must Enter Grounds At West Stewart Street Gate Only
