Office will open at 8:00 A.M. THREE (3) days prior to scheduled race day.

All entries must be made by 11:00 A.M. 3 days before scheduled race.

O.S.R.C. and U.S.T.A. Rules to govern with exceptions.

Entry fees: Stakes Races - \$75. Overnight race - \$20. Right is reserved to refuse to accept any entry. Money divided: 50 - 25 - 12 - 8 - 5 percent.

Track will score 8 wide and may be split on 10. One heat plan.

All races must have five to enter comprising four separate interests. If advertised races do not fill, Race Clerk will try to arrange other races for horses on the grounds. If in any overnight event, more entries are received than we are able to score in two tiers, we reserve the right to elimination heats.

Horses are brought on grounds at owners' risk. The Association assumes no liability for accidents, but will do everything possible to avoid them. Colt Stake Races will be raced under the Ohio Colt Racing Association rules. Any horse that is on the Steward's list for "Bad Actor" is ineligible to start. Veterinarian on grounds.
